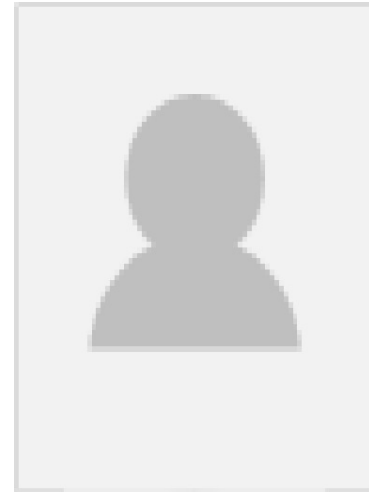

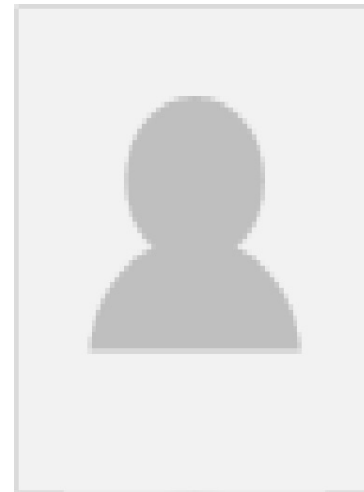

<b>Pharmacological Therapies:</b> Provides care related to the administration of medications and monitors clients who are receiving parenteral therapies.	<b>BELOW THE PASSING STANDARD</b>
<b>Reduction of Risk Potential:</b> Reduces the potential for clients to develop complications or health problems related to treatments, procedures or existing conditions.	<b>BELOW THE PASSING STANDARD</b>
<b>Physiological Adaptation:</b> Participates in providing care for clients with acute, chronic or life-threatening physical health conditions.	<b>BELOW THE PASSING STANDARD</b>
<b>Clinical Judgment:</b> The observed outcome of critical thinking and decision-making. It is an iterative process that uses nursing knowledge to observe and assess presenting situations, identify a prioritized client concern, and generate the best possible evidence-based solution in order to deliver safe client care.	<b>BELOW THE PASSING STANDARD</b>
<b>Recognize Cues:</b> Identify relevant and important information from different sources (e.g., medical history, vital signs).	<b>BELOW THE PASSING STANDARD</b>
<b>Analyze Cues:</b> Organizing and linking the recognized cues to the client's clinical presentation.	<b>BELOW THE PASSING STANDARD</b>
<b>Prioritize Hypotheses:</b> Evaluating and ranking hypotheses according to priority (urgency, likelihood, risk, difficulty, time, etc.).	<b>BELOW THE PASSING STANDARD</b>
<b>Generate Solutions:</b> Identifying expected outcomes and using hypotheses to define a set of interventions for the expected outcomes.	<b>BELOW THE PASSING STANDARD</b>
